

Professor Peter Draper – is Executive Director of the Institute for International Trade in the Faculty of the Professions, University of Adelaide, Australia.

Peter is a member of the Board of Trustees of the International Chamber of Commerce's Research Foundation; non-resident senior fellow of the Brussels-based European Centre for International Political Economy; Associated Researcher at the German Development Institute (DIE); and a Board member of the Australian Services Roundtable.

Peter is a recipient of an honorary Doctorate degree from the Friederich Schiller University in Jena, Germany.

For ten years Peter was, respectively, member, chair, vice chair, and co-chair of the World Economic Forum's Global Future Council on the Global Trade and FDI system. Peter was also Senior Research Fellow at the South African Institute of International Affairs.

Previously, Peter worked in South Africa's national Department of Trade and Industry in bilateral economic relations (East Asia and Mercosur), and as head of the economic analysis and research unit in the dti's International Trade and Economic Development Division.

Prior to that Peter was an academic teaching economic history and political economy, and headed the Department of Economics and Economic History at the then University of Durban-Westville (now University of KwaZulu-Natal).
